- **1. Minutes** (*Gerie Kay*) October 4, 2023 Minutes were approved.
- **2. Treasurer's Report** (*Reinhard Taylor*) The Treasurer's Report was approved. Most of the IRTA Convention expenses have been reimbursed.
- **3. President's Report** (Jane McCauley) We reviewed the 2023 Biennial Conventional Report as sent to us by Area 2 Rep Wendy Wiegers. Our Unit had 10 delegates. We were a **Unit of Distinction**. Elizabeth While was our Unit Honoree. Rainy Kaplan is the newly elected IRTA Vice President. Bob Lyons is Regional Director. The new IRTA Executive Director (paid staff) is Jessica Newbold Hoselton.

Resolution for state dues increase approved: Dues deduct will be \$3.50 per month (\$42 a year) and Life Membership will increase from \$400 to \$600 after Dec.31.

Constitutional change passed: Prior to the Biennial Convention, **all active members** shall have the ability to elect State officers and Area Representatives in their respective areas electronically or written. See Wendy's report for more details.

Legislative: (Karl-Heinz Gabbey) Fall Veto session is in process. Public Act 100-0465 Invest in Kids Act 35ILCS is due to expire but may be extended. This Act allows income tax credits for taxpayers who make authorized contributions to a Scholarship Granting Organization (SGO). The SGOs, in turn, provide scholarships for eligible Illinois students to attend qualified non-public schools in Illinois.
