#### **The 2014 TRAIL Open Enrollment Period will be held October 15th through November 15th with coverage elections and changes effective January 1, 2015**

Members of the following group insurance programs must be enrolled in Medicare Parts A and B in order to be eligible for the Total Retiree Advantage Illinois (TRAIL) Program. In addition, any covered dependent must also be enrolled in Medicare Parts A and B in order to be eligible for TRAIL coverage. If either the member or any dependent on the member's insurance through the State is not enrolled in Medicare Parts A and B, neither will be eligible for TRAIL Medicare Advantage plans. Members and dependents of non-Medicare households must seek benefits under the non-Medicare programs offered by the State, which are described on the Benefits website at [www.benefitschoice.il.gov](http://www.benefitschoice.il.gov).

## TRS REPORT by Bob Lyons, Elected Annuitant, TRS Board



Some time in the last month, membership in the Illinois Retired Teachers' Association passed 36,000 members. These were not only newly retired teachers, many were previously retired who were reached by a retired friend and urged to join to help protect our benefits. As you know, the IRT joined with other public employees associations and teacher unions to sue the State of Illinois on the constitutionality of their attempt to reduce the guaranteed annual 3% increase of our pensions. A growing number of retired educators have come to realize that joining our ranks and contributing to our organization's Legal Fund is literally an investment in their own future. The IRTA has already raised over \$411,000 from our members and already we have spent \$295,000 on lawyer fees. The reality is we have really spent twice that since we joined with the Illinois Association of School Administrators to split our costs. Obviously we picked the best law firm that we could find with a noted expertise in Illinois Constitutional law and to get the best, you have to pay for the best. With multiple organizations there are multiple law firms, and since they all have to talk to each before and after every legal step is taken, there is an additional expense.

Fortunately the Constitution is on our side and the Illinois District judge that is hearing the case has given every indication that he will rule in our favor before the end of the year. Of course, that will not be the end of the matter and the loser will apply directly to the Illinois Supreme Court. This is taken from the IRTA website:

*The State of Illinois Supreme Court ruled on the case regarding State Retiree Health Insurance, Kanerva vs. Weems, was UNCONSTITUTIONAL. • IRTA applauds the Illinois Supreme Court's ruling in Kanerva v. Weems. The Illinois Supreme Court has adopted a broad interpretation of the Pension Protection Clause that fully supports the interpretation advanced in our case Heaton v. Quinn. • The Illinois Supreme Court has held yet again that, under the Pension Protection Clause of the Illinois Constitution, pension benefits shall not be diminished or impaired. This is entirely consistent with Illinois Supreme Court precedent dating back several decades. We believe that the Illinois Supreme Court's consistent enforcement of the Pension Protection Clause merits serious attention from our political leaders. • In Kanerva, the Court reaffirmed that "it is clear that if something qualifies as a benefit of the enforceable contractual relationship resulting from membership in one of the State's pension or retirement systems, it cannot be diminished or impaired."*

You can do two things to help us help you. Recruit another member to our local and state organization. Our state campaign, **One Brings One**, could double our membership before the end of the year. The other action is to contribute to our Legal Fund if you have not already done so. It has been suggested that we give the value of one month's COLA in 2014 to the Legal Defense Fund. This money is in a dedicated fund and cannot be used for any other purpose. Can you afford not to do this?
